Terry, a member of the Ho-Chunk Nation living in Wisconsin Dells, is a chef and founder of Wild Bearies, a nonprofit organization dedicated to providing and educating about Indigenous foods and the culture around those foods.

"Wild Berries really is an indigenous outreach (organization). We like to say more than catering," she said in an interview for the 365 Amplified podcast last week. "We do it really based on the food sovereignty movement, and what indigenous food as medicine means to us as a community." *Continued on Page 7*

Appreciation for Sherrie Tussler and Her Amazing Hunger Taskforce Team

It goes without saying the immeasurable impacts of the pandemic left no portion of our daily, social, professional, and cultural lives untouched. As this unknown illness insidiously creeped into the Midwest, our towns, our workplaces, and eventually our homes, we were riddled with an uncertain future. Where was our next paycheck coming from? How can I get medical services and care with no insurance? What are we going to eat?

Whether we had response systems or not, action was needed to manage a means to ensure our communities could maintain some semblance of pre-pandemic life. The federal government quickly responded with mass appropriations to insulate the overall economy but more so, to ensure that commerce between producers and consumers could fare through our hardest times of modern history.

The Ho-Chunk Nation (HCN) was forced to make the hard decision to close the doors to our primary revenue centers, our gaming operations. For the first time since we've opened our casino doors, our selfsufficiency was embarking on its greatest challenge. Leadership was compelled to undertake our largest mass layoff and employees who depended on their livelihood quickly found themselves at a loss. Many who maintained employment under federal grants were authorized under Incident Command to work with community emergency response plans rather than work on programs that were also suspended due to no contact orders.

Food options for newly unemployed were to apply for commodities or FoodShare. However, applications were denied because the USDA was



slow to respond to offering income waivers for the many who were above income that rendered them ineligible. FoodShare allowances increased but the support was modest. At that time, the HCN Community Health Director initiated efforts to find alternative food sources to feed our communities. It was then HCN Community Health met Sherrie Tussler, Executive Director for the Hunger Taskforce who was aggressive about getting food to underserved areas, particularly those residing in rural tribal communities.

The Hunger Taskforce and their syndicated networks were able to utilize federal response funds to ensure producers could continue their operations and mobilize tons of food getting them across the state, much of which came to Ho-Chunk Country. Each week, we received over two semis of cold, fresh food and thanks to hundreds of workers and volunteers, HCN Community Health served a number of tribal members with volumes of food totaling over three million pounds to our communities.

In addition, Sherrie knew we weren't equipped to maintain the redistribution and was able to utilize ARPA and DATCP resources and direct them to the Nation. From this, comes a 26' CDL refrigerated food truck, a refrigerated van, preservation supplies, loading equipment, and a variety of assistance items. Sherrie believes in having access to good, healthy, and traditional foods especially from indigenous growers and producers to whom she kept on her top priority to purchase from.

As significant of a role Sherrie has played with ours and many other communities, she was as much as a "worker bee" with her colleagues and the many she friends she made across Indian Country. After recently learning of her retirement scheduled June 4, 2024, we as a Nation cannot express the level of appreciation she truly deserves. Even when tribes couldn't meet her halfway, she always found a way to make it happen. With all of our hearts, thank you. Thank you, Sherrie and your amazing team. We'll never forget what you've done for us and the eternal friendship we now have with the Hunger Taskforce.





Harry Whitehorse International Wood Sculpture Festival Activities Explore Indigenous Heritage

Full festival schedule includes cultural presenters,

live performances and art demonstrations

The inaugural Harry Whitehorse International Wood Sculpture Festival has announced a full week of events and activities aimed at immersing the community in indigenous tradition, fostering global and cultural connections and celebrating art through the natural beauty of San Damiano Monona and Wisconsin.

"We look forward to welcoming the community to San Damiano Monona for what is sure to be a truly immersive and unforgettable experience," said Gene Delcourt artist and a founder of the festival. "Over nine days, the festival will pay tribute to the legacy of Harry Whitehorse and celebrate an artform that is significant both culturally and artistically."

The Harry Whitehorse International Wood Sculpture Festival is set to take place from June 14 to 22 at San Damiano Monona. Festival attendees can explore the property's small arboretum of trees and variety of native and migratory wildlife while experiencing live wood sculpting demonstrations by world-renowned artists, cultural performances, traditional Ho-Chunk art exhibitions, food vendors and more. Festival events and activities include:

Friday, June 14:

• The opening ceremony will begin at 5 p.m. and will set the stage for a week of celebrating art and indigenous heritage and highlight the festival's cultural significance. A Ho-Chunk Color Guard will honor Harry Whitehorse's military service, followed by traditional Ho-Chunk singing and dancing. Saturday, June 15 through Friday, June 21:

• Artists-in-Residence will hold daily working hours from 9 a.m. to 5 p.m. throughout the festival week. Attendees will witness carvings come to life in real time as the week progresses.

• Cultural presenters will demonstrate traditional indigenous artforms including black ash basketry,

contemporary painting, finger weaving, bead art, ornamental needlework, jewelry making and more.

• Chicago blues group Cash Box Kings will perform live at San Damiano Monona at 6 p.m. on Tuesday, June 18.

• Local musicians will participate in Make Music Monona at San Damiano on Friday, June 21 from 11 a.m. to 2 p.m.

Saturday, June 22:

• Artists will hold final working hours between 9 and 11:30 a.m.

• Closing ceremonies will take place at 5 p.m. and artists will present their final sculptures and talk about their interpretation of the festival theme.



Rev. Roger Wentz May 1, 1930 - April 28, 2024



Rev. Roger Wentz, 93, passed away on April 28, 2024, in Black River Falls, WI.

He was born in Sheboygan, WI, on May 1, 1930, the second son of Dr. Ivan and Viola Wentz.

A 1948 graduate of Central High School, he then went to the University of Wisconsin, Madison for one semester. While in Madison he felt God's call to the Christian ministry. He stayed out of college for a semester, then transferred to Mission House College (now Lakeland). He was graduated from Mission House College in 1953 and from Mission House Theological Seminary in 1956.

On December 30, 1955, he was joined in marriage with Frances Thundercloud at the Ho-Chunk Indian Mission near Black River Falls. After serving as Associate Pastor at Faith United Church of Christ in Milwaukee, he and Frances then served United Church of Christ congregations in Kaukauna and Sauk City in Wisconsin and in Canton, Illinois, which was his last pastorate. Frances and Roger chose Portage Wisconsin as their retirement community and later moved to the Ho-Chunk Indian Mission near

Black River Falls, where they built a home that they both enjoyed on the property where Frances had lived as a girl. They enjoyed 64 years together.

He was preceded in death by his parents, his brother Edward, his wife, their daughter Renee, and a sisterin-law, Lillian Thundercloud.

He is survived by a sisterin-law, Hattie Walker of Black River Falls, a niece Leah Ann Walker of Black River Falls, nephews Carey Walker of Fargo ND, Thomas (Wy) Walker of Black River Falls, Dan (Yamei) Wentz of Mantorville MN, and Steve (Marie) Wentz of Neillsville WI, and by other relatives and friends.

In keeping with his wishes, he will be buried next to his wife, Frances, at the Ho-Chunk United Church of Christ Cemetery.

With gratitude for God's goodness and love in this life, which came through many, many people, he rejoices for the joy of entering the heavenly home prepared for all who trust in Jesus Christ as Lord and Savior. May the rich and abundant joy of God in salvation also fill your hearts.

Visitation will take place at 12:00 noon on Saturday, July 6, 2024 at the Ho-Chunk United Church of Christ, followed by a memorial service at 1:00 p.m. The service will be followed by a meal.

The Office of the General Council (OGC) has respectfully requested the Legislature for one of following two options 1. Legislative Special Meeting be called to address a Budget Overview & Justification for the Office of the General Council Agenda time during the upcoming June 4, 2024 Legislative Regular Meeting to discuss the Office 2. of the General Council Budget Overview & Justifications. This request was made due to the prior Legislative Finance Commission Special Meeting Budget Recommendation made on May 15, 2024: Motion made by Legislative Finance Commissioner Paul Fox: Motion to recommend approval of fiscal year, 2024 fiscal year, 2025 Office of the General Council Budget, in the amount of \$683,318.00 inclusive of each line item as an individual appropriation for the purpose noted for each, for inclusion to the final appropriations budget bill, this includes Advocate, Deputy Advocate positions funded for six months of the year. The OGC is requesting all of these measures to preserve the employee line item. Reconsideration of original proposed budget at the amount of \$765,218 or a reduction request of \$81,900 from the line item 100.3000.66001.0 CONTRACT SERVICES FEES to satisfy the recommended amount of \$683,318 to preserve the full-time employment of two (2) Ho-Chunk Nation Tribal Member positions The OGC did in fact carry out all Goals and Objectives from the submitted Performance Budget Summary for Fiscal Year 2023-2024. The following points must be made known: Reduced employee line item funding has never been reduced in years of failed General Council Meetings The Finance Commission did not reduce funding when the positions were vacant and General Council Meetings failed in previous years. The Legislature and Finance Commission funded the OGC with a full employee line item when the positions were vacan 2023 Annual General Council Meeting was a success, and the General Council was able to address every single agenda item. The 2023 Annual General Council meeting was not contested in the Trial or Supreme Court. The OGC did not spend any funding on questionable items. The OGC is operating on a bare bones budget. The OGC has been reporting to the Legislature as per 1 HCC § 18 Establishment Act. (The Legislature demanded this reporting to the point of requesting Attorney General Seifert to author a AG Opinion when the position of the General Council Advocate was vacant) The OGC has established Policy in regard to tribal member reporting and communication. The OGC Secretary cannot carry out the function of submitting the annual budget. OGC Secretary cannot carry out the functions pertaining to Treasury matters, payroll and personnel matters, and administrative office functions as these are only authorized to be performed by the General Council Advocate per 1 HCC § 18 Establishment Act.

Additional points of interest to be considered:

Ho-Chunk Nation Employee Relations Act (6 HCC § 5)

h. Protections Related to General Council Meetings. (2) No person shall harass, threaten, intimidate, suspend, or terminate, without Due Process, any employee for providing administrative support to an Annual General Council Meeting of the Ho-Chunk Nation or Special Meeting of the Ho-Chunk Nation General Council.

• (6 HCC § 5)

8. Definitions. Whenever the following terms are used in this Act, they shall have the meanings indicated.

z. Employee. Any individual employed by the Ho-Chunk Nation, regardless of the source of the funds by which the employee is paid. The term "employee" shall include any person elected or appointed. The Nation further classifies its employees as follows

(7) Exempt Employee. An employee classified by the Nation as exempt is salaried. Such employees are those occupying executive, administrative, professional positions, appointed, and elected officials. Weekly salary is computed using the position's annual fixed salary. Such employees may be required to maintain a contract for employment with the Ho-Chunk Nation, if required by a legislative enactment.

(6 HCC § 5)

 b. An individual on the Recall List may gain re-employment with the Nation by two (2)
means

(1) An individual shall be recalled to the position held at the time of the layoff if the position is to be filled while they are on the Recall List. Supervisors must recall said individuals before posting the position, even if they have taken another position pursuant to section b(2) below.

(2) An individual on the Recall List may apply for a posted position. All individuals on the Recall List that apply for a position shall be presented to the hiring supervisor, who shall select one applicant who meets the minimum qualifications. If only one applicant on the Recall List applies and meets the minimum qualifications, that individual shall be hired. Ho-Chunk Preference shall apply in utilizing the Recall List, meaning that if two applicants on the Recall List are presented and both meet the minimum qualifications, the position shall be provided to the Ho-Chunk el is empowered nher The Da partment of Perso ensure fl hiring qualified individuals on the Recall List, and may overrule a hiring supervisor if they refuse to hire an applicant who meets minimum qualifications. If no employee on the Recall List applies for a position, it shall be filled as normal and consistent with all other applicable rules and laws.

(This is an administrative office function delegated to the General Council Advocate.)

 Noted for the record from the Legislative Regular Meeting on July 19, 2022; NOTED FOR THE RECORD:

Rep. Kristin White Eagle mentioned there is a court order that is public information. The Trial Court has already endorsed that the Office of General Council does have the delegated authority to plan and organize the General Council meeting. The Trial Court has made a decision that is CV 21-15 filed September 16, 2021.

Below is the complete transcript for the motion made by Finance Commissioner/Legislative Representative Fox for the May 15, 2024 Legislative Finance Commission Special Meeting. This is being included so that the General Council Members are completely aware of the actions and discussion that took place.

Transcript from the May 15, 2024 Legislative Finance Commission **Special Meeting**

District 2 Legislative Representative/ Finance Chairwoman Kristin White Eagle (Rep. White Eagle):

Next, we'll go to Office of General Council. Any action from commission? Rep. Fox?

District 4 Legislative Representative/ Finance Commissioner Paul Fox (Rep. Fox):

Thank you. Madam chair. I'd like to make a motion to recommend approval of fiscal year, 2024 fiscal year, 2025 Office of the General Council Budget, in the amount of \$683,318.00 inclusive of each line item as an individual appropriation for the purpose noted for each, for inclusion to the final appropriations budget bill, this includes Advocate, Deputy Advocate positions funded for six months of the year

District 4 Legislative Representative/ Finance Commissioner Brianna Tahdooahnippah (Rep. Tahdooahnippah): Second for discu

(Rep. White Eagle): Second for discussion by Rep. Tahdooahnippah. Go ahead Rep. Tahdooahnippah.

(Rep. Tahdooahnippah): So does the advocate in the deputy Advocate job descriptions match? Or what they support, that six months per out of the year?

(Rep. White Eagle): Rep. Tahdooahnippah, who is you question too?

(Rep. Tahdooahnippah): Anybody

General Council Advocate Nathaniel Longtail Jr. (GC Advocate Longtail): Madam chair?

(Rep. White Eagle): See ah any commission members any discussion or answer or go to Nate. Hello Nate, you might want to speak up.

(GC Advocate Longtail): Hello. This is Nathaniel. I'm not I'm not sure if you can hear me - very good.

(Rep. White Eagle): Now we can Yes

(GC Advocate Longtail):

So I just wanted to say a few things on behalf of this because I believe \$683,318 isn't what we put in for our budget submission, and I just want to state that I believe The question is that, our, our job descriptions match in, in support of the budget recommendation, I would have to say, no, I believe the job descriptions are-are for regular full-time employees. I don't want to get too much into Personnel related instances on this.

But I would like to state that on January 19, 2017 the Legislature enacted the General Council Organization and Establishment Act, and that act established that the Office of General Council by law and observance and furtherance of General Council Resolution 9-17-2016-01, and within that, later on it states: Internal Organization and Authority under Section 5. (A), says consistent, the word consistent is used with General Council Resolution, 9-17-2016-01. The Office of General Council shall the word "shall," is used, consists of the following positions, General Council Advocate, Deputy Advocate and General Council Secretary.

Now, when we go back to that resolution that they're supposed to be consistent with It talks about in the first page, that in 2003, the General Council passed a resolution 10-11-03, that proclaimed Office of General Council be created for the purposes of enforcing the wishes of the General Council, and the Office of the General Council oversees such operations of the General Council. So as this as that as that establishment act is consistent with this resolution, and this resolution Um brings up resolution 10-11-03L. I would like to read the statement from that resolution. General Council Resolution 10-11-03 which was submitted by tribal member Robert Funmaker was, now therefore be it resolved that the General Council of the Ho-Chunk Nation take action to create an Office of General Council for the purposes of enforcing the wishes of the General Council that the Office of General Council oversees such operations and that the Legislature appropriate the funds necessary to operationalize the office with "salary," office space, telephone, fax, transportation, and other necessary means to bring such office into reality within one month of today is date.

So, we submitted a budget that included all three job descriptions to be in support of the Establishment Act, to be in support of resolution 9-17-2016, and to be in support of resolution 10-11-03 that was submitted by Mr. Funmaker, because we did not want to um, go against the wishes of the General Council. So that is why our General Council budget is submitted in that manner, and then I did want to thank you representative Fox for, um, your opening prayer and you're opening statement to include blessings over all the employees, that was, that's a very awesome that you would pray for us that way. But then only want to make a recommendation to fund us for six months, but thank you for that blessing. Um, and that's I think all that I wanted to um say at this time. Thank you for the discussion

(The OGC Secretary is not capable of performing these duties per the Office of the General Council Establishment and Organization Act to reinstate employees from recall list after a layoff)

SECTION 18 – OFFICE OF THE GENERAL COUNCIL ESTABLISHMENT AND ORGANIZATION ACT (1 HCC § 18)

b. The General Council Advocate will oversee the Office of General Council and will supervise the other positions, as described in any legislatively approved job descriptions. Further, the General Council Advocate will have the authority to hire additional staff pursuant to the Nation's Employment Relations Act (including limited term employees); rovided, however, that such hiring shall be consistent with the approved budget of the Office of General Council and any contract authority that is either reserved to the Legislature or delegated to the Office of General Council.

c. The General Council Advocate will have signature authority similar to that of an Executive Director of a Department of the Nation, including such authority for budget and Treasury matters, payroll and personnel matters, and administrative office functions, consistent with the approved job description for the position and the budget of the Office of General Council. In the absence of the General Council Advocate, the General Council Deputy Advocate will have similar signature authority.

The General Council Advocate will have the right to prepare and present the annual budget to the Legislature in accordance with the Appropriations and Budget Process Act ("Budget Act") of the Ho-Chunk Nation, including the right of the Advocate to request budget modifications from the Legislature, consistent with the Budget Act.

(These are administrative office functions are only delegated to the General Council Advocate.)

Man who disrupted Baraboo graduation charged with disorderly conduct

The man who disrupted the Baraboo High School graduation last week by charging onto the stage and pushing superintendent Rainey Briggs has been charged with disorderly conduct, court records show.

Matthew Eddy, 49, faces up to 90 days in prison, a \$1,000 fine, or both.

Additionally, a Dane County judge granted Briggs a temporary restraining order against Eddy, with an injunction hearing set for next week.

Video captured by TV43 Baraboo shows Eddy jumping onto the stage just as Eddy's daughter begins to cross the stage to receive her diploma. Eddy grabbed Rainey's upper arm and forced him away from the line of school officials congratulating graduates. Rainey can be heard saying "you need to get up off of me, man ... get away from me, bro."

In his application for a restraining order, Rainey wrote that Eddy said, "'you are not going to touch my (expletive) daughter."

Parent Duranceau captured the incident from the audience perspective. According to a police report, Eddy told officers that he and his daughter "have had past issues with Rainey and dislike him." Rainey told police he didn't know Eddy and could only remember one disciplinary issue involving Eddy's daughter.

The school resource officer and others escorted Eddy off of the stage, and he left the ceremony. Rainey returned to the handshake line about a minute later, and told police he felt anxiety for the rest of the ceremony.

In a statment issued Thursday, Blacks for Political and Social Action of Dane County president David Hart and vice president Kirby Mack noted that Briggs was the only Black person on the stage at graduation.

"After Dr. Briggs was pushed out of the way and prevented from doing his job, it does not appear that anyone checked on Dr. Briggs' welfare, and he was forced to continue on amid this trauma," they wrote. "While this incident could certainly have race neutral explanations, the treatment of Dr.Briggs looks all too familiar to us ... After Dr. Briggs was pushed out of the way and prevented from doing his job, it does not appear that anyone checked

They also referenced a 2018 incident in which Baraboo students were photographed giving a Nazi salute in a prom photo. Questions of racism were also raised in 2022 when Baraboo High School's athletic director and two other men were arrested for threatening teens with a flamethrower and forcing them to kneel in the street when they suspected the boys intended to play a Homecoming prank.

The Baraboo School Board issued a statement Tuesday condemning Eddy's actions.

"As we prepare our students to engage as citizens and community members, the adults in their lives should provide models of how to engage in productive civil dialogue," the release reads, in part. "What we do not condone is engaging in threatening, intimidating, or physically harming behaviors against anyone in our School District community. No employee of the School District of Baraboo should fear for their physical safety when fulfilling their job duties or at any other time. That this adult felt emboldened to behave in this way in front of hundreds of students and other adults should deeply trouble us all; this type of behavior will not be tolerated."

PROTECT OUR COMMUNITIES FROM SCAMS

Everyone has a right to safety and justice. However, it is estimated that millions of older adults, from all walks of life encounter harmful scams every year. We are not providing the necessary supports needed to keep everyone safe and engaged as we age. Ageism (biases against or stereotypes about older people that keep them from being fully a part of their community) also play a role in enabling elder abuse. By changing these contributing factors, we can prevent elder abuse and make sure all of us have the opportunity to thrive as we age. Here are things we can do to help protect our communities from abuse and neglect

Build Supports

If we think of society as a building that supports our wellbeing, then it makes sense to design the sturdiest building we can-one with the beams and a solid foundation and walls necessary to keep everyone safe from scams and healthy as we age.

- 1. We can construct community supports and human services for family caregivers and older adults to alleviate risk factors tied to elder abuse like ageism (bias against older adults in our culture) or social isolation
- 2. We can increase funding to support efforts to train service providers in how to prevent and detect scams when working with older adults
- And we can create, maintain and improve organizations like consumer protection agencies that work to stop scams and make sure companies, banks and lenders treat us fairly.

Is It A Scam?

- 1. Is the sales person using high pressure sales tactics? Scams often say things like, "Act Now!"; "Time is running out!"; "This is a onetime offer!"
- 2. Are you being asked to pay upfront fees? Lottery and sweepstakes scams often employ this tactic. If you really won something the fees can be taken out of your winnings
- Are you being told that you won a contest that you didn't enter? Lottery and sweepstakes scams almost always start this way. You can't win a contest that you didn't enter
- Have you been scammed in the past? Often scam victims have their personal contact information sold to other con artists. You may get unsolicited calls from people promising to get your money back or provide other remedies or offers. These 'offers' can be scams too. Beware!

5. Did you receive unsolicited mail, emails, or phone calls for services that you were not seeking? Research the companies that you want to employ. Many scams begin with someone knocking on your door offering services, or sending out promotional materials. This often happens in the case of home repair scams.

6. Are you being contacted by the police over the phone? Verify that they are who they say they are. Some scams begin with a person pretending to be a police officer who tells you that they are concerned that you have been a victim of a crime. They then proceed to solicit your personal information. In truth, the police will contact you in person if they have questions for you or believe that you have been a victim of a crime.

How To Protect Yourself

- 1. Sign up for the Do Not Call Registry at <u>www.donotcall.gov</u>.
- 2. When no longer needed, shred junk mail, old bills, bank statements and any other documents that have personal identifying information.
- 3. Don't give out personal information over the phone unless you originated the call and you know with whom you are talking. Particularly safeguard your social security number
- 4. It is ok to be rude. If a sales person calls you or comes to your door who does not seem to be taking no for an answer, it is ok to terminate the conversation. Hang up the phone or close the door. You don't have to let yourself be pressured into anything.
- 5. Never sign something that you don't understand. Have a trusted and unbiased professional assist you when enter contracts or signing legal documents
- If you hire someone for personal assistance services, in home care services, etc. ensure that they have 6. been properly screened with criminal background checks completed.

the chefs on the importance of food in Native cultures.



The Ho-Chunk Language and Culture Committee shall be appointed by the Ho-Chunk Nation Legislature ..to establish policy and make decisions regarding the Ho-Chunk language and culturally related issues as defined in Section 16 Duties, Obligations and Responsibilities.

In accordance with Ch. VI Language and Culture Committee, the Language and Culture Code states:

12. Composition. The Ho-Chunk Language, Culture and Traditions Committee shall be composed of Ho-Chunk Nation Elite Elders, Elders and Ex-Officio representatives from programs or projects currently providing Ho-Chunk language instruction and cultural preservation for the Ho-Chunk Nation.

- a. The Committee will consist of seven (7) voting members, Three (3) Elite Ho-Chunk Elders, Four (4) Ho-Chunk Elders and will be formally appointed by the Ho-Chunk Nation Legislature.
- c. The Ho-Chunk Language and Culture Committee members shall serve for a three (3) year staggered term. The term of the Ho-Chunk Language and Culture Committee members shall begin on January 1 following appointment at the November meeting of the Ho-Chunk Language and Culture Committee. Ho-Chunk Language and Culture Committee appointed to fill a vacancy caused by resignation, death or removal of a member shall serve for the remainder of the 3-year term. Ho-Chunk Language and Culture Committee members may be reappointed without limit to number of terms.

The majority of the current board members are Elite Elders. Tribal members age 60 and above may be nominated or may self-nominate by sending a letter of interest to Adrienne Thunder, Language Division, <u>Adrienne.thunder@ho-chunk.com</u> or to P.O. Box 667, Black River Falls, WI 54615.

Continued from Page 7 beef or chicken. The dishes they came up with ranged from roast rabbit with acorn squash polenta cake to duck breast with braised mustard greens to sunflower choke with braised goose.

"We got to come in past the halfway point. We were after Restaurant Wars," the turning point episode that happens midway through every season, Terry said. "We really got the chefs who are driven, who are transforming their cookery, who are getting inspired on these different levels. They rose to the challenge, and there was not a bad dish served to us."

Terry said her hour in the national culinary spotlight hasn't led to a lot of new opportunities – mostly because her slate was already full.

"We have 100% proof of success. Every single one of our culinary apprentices has found full time employment, which kind of leaves me in a tough situation to be saying yes to a lot of things," she said. "That being said, we have incredible opportunities. We're going to the Smithsonian Folklife Festival as part of an ongoing partnership that Wild Bearies has developed, and we're able to bring along three young women who are all studying environmentalism in some form, and advocacy. We're able to provide opportunities like that, and then kind of take a step aside while we rebuild

our culinary mentorship program. It has been work that we've been doing in our community."

Still, the experience had a profound impact on Terry and how she views her work.

"I'm an incredible introvert. I love being in the kitchen, behind the scenes, running the show," she said. "So putting myself out there like that takes a lot of courage. And in our communities, unfortunately, there's a lot of lateral criticism, and to be so well received and celebrated. And to say this is a transformative moment to have representation ... not only Indigenous, but chefs out there. We're experts, and we can be heard in these great spaces. It's representation on so many different levels. How can I not take that moment and take it in? It's just been incredible for me to be able to feel so strong and grounded from it all."
