Jebette was taught by her grandmother as a young girl and was eager to share her knowledge and skills with us. It was a wonderful weekend, and we hope to have her back soon for part two!

Leslie is also running eight book clubs and two art clubs in conjunction with Josie Lee and Liza Green. Between them all, there are over 200 students who have received age appropriate books from Native authors as well as working on their reading and discussing the content of each. Congratulations to all those families working hard to keep their reading skills sharp!

Mandy Youngthunder (Student Service Specialist) hosted an event with Ho-Chunk author Sherman Funmaker. Sherman entertained attendees with stories from growing up, his writing history, and his poetry. There was a lot of laughter shared that night. Next we will be hosting Sherman at the District 2 Community Center in Tomah August 1st from 5-7pm. He offered a field trip to his Traditions 101 students at Perrot State Park. Families met Hushi at Perrot State Park in Trempealeau, WI where he lead them on a tour of two mounds and provided information on the history and cultural significance of mounds. To end the field trip he took families to an overlook of Trempealeau Mountain where he told the cultural significance and stories of the mountain. It was a valuable experience for the whole family!

Starting July 11, Barb Blackdeer-Mackenzie (Grant Administrator) provides her first class this summer called Circle Teachings. It will be an online class that is based off *Teachings of the Medicine Wheel* by the late Charity Thunder. Topics cover identity, self-care, and more! Barb is excited to get her class underway! Ho-Chunk Nation Legislature selects Representative Danielle DeLong as Vice President

NJOXAWANJ, Black River Falls, Wisconsin – The Ho-Chunk Nation Legislature selected a new Vice President, District 4 Representative Danielle DeLong. Former Vice President Karena Thundercloud resigned July 6, 2024, and the Legislature voted Rep. DeLong to fill the position. This is the first time the Ho-Chunk Nation has voted for an At-Large representative as Vice President.

Rep. DeLong has a Bachelor's degree in Elementary Education and Spanish Language and a Master's degree in Tribal Administration & Governance. Before being elected, she spent over 20 years as a teacher, including seven years with the St. Paul Public Schools Indian Education Program. Previously, Rep. DeLong was the Center Director for the HCN Youth Services Program in St. Paul. In her free time, Rep. DeLong enjoys escaping the *Continued on Page 2*

MOWA presents first-ever comprehensive exhibition of Ho-Chunk baskets

Weaving a Legacy: Ho-Chunk Black Ash Basketry is a monumental act of cultural identification and preservation.

West Bend, WI - Museum of Wisconsin Art is thrilled to announce Weaving a Legacy: Ho-Chunk Black Ash Basketry, an exhibition which introduces audiences to the historically important and visually striking tradition of Native basketmaking in Wisconsin. Featuring 200 baskets by more than 40 Ho-Chunk makers from the mid-1800s to the present, this groundbreaking exhibition presents this subject for the first time. In addition to images of the baskets, the accompanying catalogue includes historical photographs. It will be the

definitive book to date on the topic. The exhibition opens August 3, 2024.

Weaving a Legacy is curated by Ho-Chunk artist and University of Wisconsin-Madison Professor of Photography Tom Jones, who has collected Ho-Chunk baskets and pieced together tribal history for more than a decade. This exhibition celebrates Jones's act of cultural preservation: photographing and documenting more than two thousand baskets from the mid-1800s through to contemporary work. Until now, no exhibition, book, or even brochure has ever been produced on this history.

"This project raises serious questions regarding historical and gender-based injustice, the cultural impact of tourism, and the importance of primary Indigenousdriven research to reset the art historical canon," said Laurie Winters, James and Karen Hyde Executive Director. "Exhibitions such as this one that enable us to draw in new audiences and viewpoints fulfill an important tenet of MOWA's institutional mission."

Black ash basketry emerged in Wisconsin by the 1820s. It took inspiration from the Indigenous tradition of hand-woven twill and

wool mats, rugs, and panel bags, as well as the later practice of ribbonwork appliqué, which incorporated European trade goods into Ho-Chunk designs. Works in the exhibition are organized by shape and function to reflect the specialization of the makers who often developed highly distinctive, recognizable weaving styles. "Contemporary works establish Ho-Chunk basketry as an enduring and still evolving art rooted in uniqueness and individual expression," said curator Tom Jones. Helen Lonetree, Ruth Cloud, and Sarah White Eagle, whose works are collected by major American art museums, are prominently featured.

Join us as Weaving a Legacy gives voice to the region's cultural heritage, commemorating the beauty and craftsmanship of Ho-Chunk basketry. The exhibition runs August 3-November 10, 2024.

Ho-Chunk Nation Tribal Members will still receive July and August payments. This General Welfare application must be completed by August 15, 2024 to receive payments for September and the rest of the fiscal year payments. Minors do not need to complete an application unless they are turning

18 this 2024/2025 fiscal year. If you already completed this application you do not need to re-submit.



The Legislature has adopted resolution 6-18-24V to provide general welfare assistance to all Tribal members through the next fiscal year. FY2024-25 budget will contain funds to provide \$1,000 to all Tribal members each month. With the minor Tribal members receiving \$250 paid directly to them for the months of August, November, February, and May, with the remaining \$750 to go into their trust accounts.

Three **Rivers** Feasibility Study update from Director Rave

Rep. Kristin White Eagle provided a re-cap on the Three Rivers House. About a year ago there was funding allocated to do a feasibility study. D2 Legislators started working with the community to see what they wanted to do with the building. The building is extremely old and renovations will be would be in the millions to renovate. Three Rivers House is registered as an historical landmark. The community was interested in renovating the building or looking for another property. The EDOA came back and stated there is extensive work that needs to be done to that property. The community is now interested in building on a new site or purchasing a new building.

Executive Director of Administration Michael Rave mentioned there had been previous structural evaluations done however he cannot locate the studies. There are extensive issues with the foundation, HVAC, ADA accessibility, elevator, and plumbing. There are issues that cannot be addressed such as parking, drop off spots and ADA accessibly to the other floors in the building. The elevator is very outdated. It will take several million to renovate.

NOTICE AND RULES OF SPECIAL ELECTION Monday, August 5, 2024



LEGISLATOR DISTRICT 1, SEAT 1

Notice is hereby served to all eligible voters of District 1. The Ho-Chunk Nation is calling a Special Election which will be held due to the Resignation of Legislator Karena Thundercloud, District 1, Seat 1 effective July 6, 2024. The Ho-Chunk Nation Election Board, in accordance with the Constitution of the Ho-Chunk Nation will conduct a Special Election. ARTICLE IX< SECTION 10, Removal, Recall and Vacancies and the Election Code 2 HCC Sec. 6, states in relevant part:

ARTICLE IX-REMOVAL, RECALL VACANCIES

Section 10. <u>Vacancies in the</u> <u>Legislature</u>. If a vacancy occurs in the Legislature because of death, mental or physical incapacity, removal or recall vote, resignation, felony conviction, or for any other reason, such vacancy shall be filled in the following manner:

(a) If three (3) months or more remain before the next General Election, the Election Board shall call a Special Election in the appropriate District to be held within thirty (30) days.

NOMINATIONS OF CANDIDATES

respective district for at least three (3) months. See Election Code Sec. 11 (a) (b).

REGISTRATION:

Each person seeking to vote must register at the polling place by showing identification before receiving an Official Ballot. If a person cannot write, that person must sign his/her name with a mark before two (2) witnesses

ELIGIBILITY DISPUTES:

Any individual whose name does not appear on the eligible voters list can claim the right to vote by presenting a written challenge to the Election Board. Any eligible voter may challenge the eligibility of an individual's name appearing on the eligible voters list by presenting a written challenge to the Election Board.

The Election Board shall rule on all written challenges to the list of eligible voters immediately after the close of the challenge period, Section 11. c. *ii*. (Deadline, Tuesday, July 16, 2024).

ABSENTEE VOTING:

A voter may vote by absentee ballot provided the Election Board receives the absentee ballot request in writing no later than Saturday, July 27, 2024, **by 4:30 P.M.** See *Election Code, Page 26, Sec. 13 (a) (i)*.Requests MUST INCLUDE the eligible voter's name printed or typed (with signature), physical address where the ballot will be delivered (we use UPS next Day Air – UPS Next Day Air will not deliver to a P.O. Box), daytime telephone number and enrollment number.

Absentee Ballots must be received before 7:00 pm on Monday, August 5, 2024.

CONTESTING OF ELECTION RESULTS:

Any member of the Ho-Chunk Nation may challenge the results of any election results within ten (10) days after the Election Board certifies the results. The Trial Court shall hear and decide a challenge to any election within twenty (20) days after the challenge is filed in the Trial Court.

ELECTIONEERING:

There shall be no electioneering within fifty (50) feet of any polling places.
