This December you might consider purchasing this book for your young reader, We Are Water **Protectors** by Carole Lindstrom. Carole Lindstrom is Anishinaabe/Metis and has written several young reader books. This book is the 2021 Caldecott Medal Winner and as the title of the book suggests, it is written to express concern for the environment. It is about much more than the environment as it written from the viewpoint of a young Indigenous girl and a recent incursion upon Indian lands.

The illustrator, Michaela Goade, is enrolled with

the Central Council of the Tlingit and Haida Tribes of Alaska. The book is filled with brightly colored watercolor pages showing the beauty of nature and the menacing black snake.

She begins narrating the book with the words, "Water is the first medicine, Nokomis told me". The story centers around taking care of the water and nature and taking a stand for those who cannot speak against the black snake. Additionally, it refers to Native resilience and environmental protests against one of these giant pipeline companies, perhaps this

is why, in Pennsylvania, the book was challenged. I hope you and your children enjoy this book and think about its relevance today; for an adult it is a very short read and long on meaning.

Michael Day Debuts "Everett LoneWolf" at 3 Rivers Lacrosse Area Office

On November 22, Michael Day, a Ho-Chunk member of the Bird Clan, celebrated the launch of his latest book, Everett LoneWolf, at the 3 Rivers Lacrosse Area Office.

Writing under the pen name Kunu, Day offers a deeply personal yet fictional narrative exploring the spiritual awakening of an urban Native American who reconnects with his heritage through the Lakota Way of Life.


"I wrote this book because I wanted people to understand more about Native people," Day said. "Not just people living on reservations, but what it meant to be an Indian in an urban setting. There's a big difference in how we live our lives."

Everett LoneWolf is a fictional tale chronicling the spiritual awakening of an urban Native American in Chicago, blending cultural and historical narratives. Through the protagonist's journey, readers experience iconic events in Native American activism, such as the occupation of Wounded Knee in 1973 and the Longest Walk of 1978, as well as sacred ceremonies like the Vision Quest and Sun Dance.

"I met a lot of people like this," Day said. "Urban Indians who didn't know their traditions or culture. They lived their lives disconnected from their roots, knowing powwows but not the deeper spiritual aspects of being Native."

Day's own experiences as a Ho-Chunk man influenced much of the narrative. He shared memories of growing up in a ciporoke—a traditional shelter—after his family lost their home, and how his father's resilience inspired him to find strength in adversity.

"I'll never forget my father holding my hand and saying, 'Son, we can start over again.' That moment stuck with me," Day said. The book's introduction, written by Arvol Looking Horse, 19th Keeper of the Sacred White Buffalo Calf Pipe, highlights its cultural significance. Looking Horse described Everett LoneWolf as "a



looking glass view into the struggles of living within traditional ways" in an urban setting, capturing both the challenges and beauty of preserving Native identity.

For Day, Everett LoneWolf is more than a novel, it's a call to reconnect with cultural roots and foster understanding.

"I want people, Native and non-Native, to understand that our traditions aren't just relics. They're alive, and they have lessons for all of us," Day said.

He hopes the book will inspire readers to see the world differently, adding, "Every story in this book has a teaching. I want it to be something you carry with you, something that helps you grow."

The event concluded with Day signing copies of Everett LoneWolf, emphasizing his gratitude to those who attended.

"It means a lot to me for you to be here. This is how we grow together."

Everett LoneWolf is available for purchase at local bookstores and online. The book offers a unique perspective on the Native American experience, blending historical events, cultural teachings, and deeply personal stories to create a compelling narrative about identity, resilience, and revival.



United Indian Nations of Oklahoma caps off two-day annual meeting with serious conversations critical to Tribal sovereignty and the well-being of Tribal communities

Topics ranged from federal Native American boarding school legislation, the missing and murdered Indigenous People crisis, and tribal priorities with new leadership in Oklahoma and the United States Congress

STROUD, Oklahoma – United Indian Nations of Oklahoma (UINO) concluded its annual meeting on November 18-19 in Stroud, Oklahoma, hosted by the Sac and Fox Nation. Changes to state and federal leadership, advocacy to pass federal legislation for a Native American Boarding School Commission, and the crisis of Missing and Murdered Indigenous People (MMIP) dominated the two-day event.

Tribal leaders, policy experts, and Native advocacy organizations tackled these critical issues in Indian Country to plan strategic action for 2025. Officers reelected were Shawnee Chief Ben Barnes, UINO board Chairperson; Wyandotte Nation Second Chief Norman Hildebrand, Vice Chairman; Muscogee Nation Principal Chief David Hill, Secretary; and Bruce Pratt (Pawnee), Treasurer. Margo Gray (Osage) continues to lead UINO as executive director.

We dealt with some heavy issues over the past couple of days. We covered everything from the MMIP crisis to health care, a second Trump administration, and who will fill key positions at the Department of Interior. We also discussed how new leadership in both chambers at the Oklahoma State Legislature will impact our issues," Gray said. "The highlight was honoring Deb Parker with the Native American Boarding School Healing Coalition. We see just how close we are to passing

form a commission seeking justice for survivors and families. Congress must pass this legislation before it's too late for our elders who lived through the boarding school era."

Annual Meeting Highlights: National Native American Boarding School Healing Coalition (NABS):

Deborah Parker (Tulalip Tribes), CEO of NABS, received UINO's National Tribal Leader of the Year award and delivered a passionate call to action on Senate Bill 1723 and House Resolution 7227, the Truth And Healing Commission On Indian Boarding School Policies Act.

Parker, along with NABS' Director Of Policy & Advocacy Dr. Ponka-We Victors-Cozad (Tohono O'odham Nation/Ponca Tribe) and Board Member Chief Ben Barnes (Shawnee) asked attendees to contact their U.S. Senators and Representatives and urge them to send S.1723/ H.R. 7227 to a floor vote before Congress swears in new members this January.

This legislation would establish a commission to seek answers on the number of Native children forced to attend government-sanctioned boarding schools, the number of Native children who were abused, died or went missing while at these institutions, and the long-term impacts on Native children and the families of children forced to attend Indian boarding schools.

The Truth And Healing Commission On Indian **Boarding School Policies Act** would allow the commission subpoena power to locate and analyze all records on Indian boarding schools from federal, state and local governments, churches and religious institutions, and private organizations. Records of primary importance include documents related to attendance, infirmary, deaths, land, and other correspondences.

of records that haven't been sorted through," Parker told the audience. "We know there are children across this country buried in unmarked graves. Our elders who have this shared experience are up in age. The truth-telling needs to happen so they feel like they have a voice. Our elders deserve that healing. We will not stop. A safe public and private convening needs to be held so we can make recommendations to Congress to help us find and identify our children. We will pass this bill and find those children."

If S.1723/H.R. 7227 does not receive a floor vote before Congress swears in new lawmakers on Jan. 3, 2025, the process of hearings, testimony and passing a new bill begins all over again. The U.S. Senate and both chambers in the Oklahoma Legislature have new leaders for the first time in several years. Attendees and panelists discussed strategies to address the legislative leadership changes and a new White House with incoming President Trump



The commission's findings will allow them to make recommendations to Congress on achieving true reconciliation and healing for Native communities.

"NABS was able to identify at least 527 U.S. boarding schools. But our work so far is only the beginning. There are millions upon millions in presidential leadership is never as bad as some think it will be or as good as others think it will be," Pipestem told attendees.

Pipestem said a rise in the power of leaders from the Great Plains region, such as Sen. Thune (South Dakota) and Department of Interior nominee Governor Doug Burgum (North Dakota), may benefit tribal relations. Pipestem and others praised Rep. Tom Cole (R-Oklahoma, Chickasaw), who remains Chair of the House Appropriations Committee, a key role for Tribal interests.

The Oklahoma Legislature has new leadership in both chambers for the first time in eight years. Attorney Fred Jordan (Cherokee) provided insight into what these changes mean for tribal on Nov. 18-19 in Stroud, Oklahoma. Newsletter characteristics take into account: topics relevant to their unique group; advice, deadline reminders, important announcements, and schedule of events; and program updates and outcomes.

StrongHearts Applauds the Appointment of Tami Truett Jerue to the Task Force on Research on Violence Against American Indian and Alaska Native Women

SAULT STE. MARIE, MI — Nov 24, 2024: The leadership of StrongHearts Native Helpline applauds the appointment of Tami Truett Jerue to the Task Force on Research on Violence Against American Indian and Alaska Native Women. Tami is the Executive Director, Alaska Native Women's Resource Center (AKNWRC) and a sitting member of StrongHearts Native Helpline's Board of Directors. As such, Tami understands the root causes of domestic and sexual violence against Indigenous people across the nation but especially in her home state of Alaska.

"We stand with our relatives in our mission to eradicate violence against Indigenous people and to promote healing in Tribal communities," said CÉO Lori Jump. "When we see Native women rising to uplift the voices of victim survivors who have been silenced by the media, we must put her on our shoulders so that she can be heard. It's time for Native women to demand justice for all of our people. When given the chance, we must celebrate Native women who stand to lift up the voices of victim survivors and advocates across the nation." The Task Force, authorized by Section 904(a)(3) of the Violence Against Women and Department of Justice Reauthorization Act of 2005 (Pub. L. No. 109-162), provides advice and recommendations on the development and implementation of a program of research that examines violence against Indian women in Indian Country and Alaska Native villages, including domestic violence, dating violence, sexual assault, stalking, murder, and sex trafficking, and evaluates the effectiveness of federal, state, tribal, and local responses to these crimes. Tami will serve alongside Catherine Edwards of the Central Council of Tlingit and Haida Indian Tribes of Alaska on the Task Force, bringing forward the voices and priorities of Alaska's 229 federally recognized Tribes in shaping national policy on tribal jurisdiction and

Chloris Alfred Lowe, Kerejusepskaga (Winter Hawk) passed away peacefully in his home surrounded by family November 6, 2024.

Chloris Alfred Lowe was the son of Mabel Davis and Martin Lowe and son of all those before him with grandparents George Lowe and Lena Decorra; John Davis and Minnie Pigeon. His ancestors and ancestors of many tribal members who read this: Charles Lowe and Mary Winneshiek, Charles Decorah and White Cloud Woman, John Davis and Lucy Nandory; Frank Pigeon and Woman Sent, Four Deer Decorah and Flying in the Village, Young Pigeon, Jennie Standingwater, Flying Low Cloud, before them many others – all gave him life and now he returns.

He was born in a ciiporoke (wigwam) "below the hill" west of the Ho-Chunk Indian Mission, December 12, 1927. Chloris was third in a family of 6 children, removed from his family at five he was taken to the Neillsville Indian Boarding School. He later attended Black River Falls High School excelling in sports and graduating in 1945. In high school Chloris met Anita Nemitz, a cheerleader for Alma Center who would become his wife. They were married 67 years when Anita passed. Chloris and Anita raised three children.

Chloris drove trucks from his late teens until retiring in 2003. He was an ardent member of the Teamsters Union, local 710. He hauled freight for millions of miles, and worked for Indianhead Trucking, Glendenning Motorways and Millis Trucking among others.

Following his retirement from trucking he worked in the Language Division of the Ho-Chunk Nation for some twenty years, into his 90s. He lent his storytelling and artistic talents to this effort.

His love of drawing and teaching the young ones is seen in his illustrated language guides. He was

well known for his art works that included drawing and painting in many media. He could quickly draw cartoons and would leave them with friends and family. He created many more detailed works of the Ho-Chunk people, capturing their lives, their stories – both past and present.

Chloris is survived by sons Chloris Jr. (Christine), and William (Rebecca), daughter JoDeen, grandchildren; Chloris III, Kjetil (Henning) Garvin, Abigail Lowe, Ashley Buntova, Avery Lowe, Allison Lowe and 12 greatgrandchildren and many other relatives.

Chloris was preceded in death by his wife Anita, his parents, brothers Clifford, Raymond, and Truman, sisters Arvina, Irene and Mildred.

A celebration of Chloris' life will be on December 18, 2024, at the District I Community Center, N7261 Warrior Ave., Black River Falls, WI. Visitation at 10 AM, Service 11:30, Meal at 12 noon.

In lieu of flowers, memorials may be given to Hospice Touch of Tomah WI for their kind care in the final days.

Hare Funeral Home of New Lisbon aided the family in the cremation and arrangements.




Bridget Antoinette Morris December 28, 1972 - November 27, 2024

The Mitchell Museum of the American Indian Rebrands as the Gichigamiin Indigenous Nations Museum: A New Era Focused on Indigenous Communities of Chicago and the Great Lakes Region

Evanston, Illinois – The Mitchell Museum of the American Indian is proud to announce its rebranding as the Gichigamiin Indigenous Nations Museum, marking a transformative milestone in its 47-year history. This new identity follows the museum's evolution into a majority Nativeled institution dedicated to honoring Indigenous communities' diverse histories, cultures, and languages across Chicago and the Great Lakes region.

The museum name "Gichigamiin" means "Great Lakes" in Anishinaabemowin (Ojibwe), a central Algonquin language spoken by the Anishinaabe people throughout the states and provinces surrounding the Great Lakes. Pronounced /GI-CHE-GAH-MEAN/, the name was carefully chosen in collaboration with the local Indigenous communities to ensure it authentically reflects the region the museum represents.

"The new name not only grounds the museum geographically, it signifies an essential step in reclaiming and revitalizing Indigenous languages and cultures," said Kim Vigue (Menominee/ Oneida), Executive Director. "By embracing an Indigenous name, we honor the remarkable resilience of the generations before us who courageously faced assimilation efforts aimed at silencing their voices and traditions. This rebranding marks a significant step toward healing and celebrating the Indigenous histories of the Great Lakes region and the vibrant cultures that continue to thrive today."

The rebranding process was fueled by extensive community involvement and driven by Bumper Lanes, a Native women-owned marketing firm. Over nine months, engagement efforts included surveys and focus groups with the Indigenous community, museum members and partners, and the public. Feedback from nearly 700 participants highlighted a broad consensus supporting a new identity that mirrors the values and languages of the Indigenous peoples in the region.

"As we step into this new era, we are honored to share the stories and traditions of Chicago's diverse Native community and the Indigenous Nations of the Great Lakes. Our museum will serve as a unique venue and vital resource for education, appreciation, and connection, inviting all to experience the depth and richness of the people who have occupied this land since time immemorial," stated Andrew Johnson (Cherokee Nation), Board Treasurer.

Graphic artist Crystal Mzhickteno, a Prairie Band Potawatomi Nation citizen, designed the new logo. The design features a Woodland floral motif and ribbon work in shades of blue and green, along with visual elements that highlight the cultural significance of the Great Lakes and reflect the region's natural environment.

To further its commitment to amplifying Native voices and narratives of the Great Lakes, the Gichigamiin Indigenous Nations Museum will



introduce two exciting programs: "Living Stories: Contemporary Woodland Native American Art," an exhibition opening on January 27, 2025, and the "Indigenous Gardening and Foodways Initiative," which will feature an expanded native garden, a teaching kitchen, and a related exhibit set to launch in spring 2025.

Missing and Murdered Indigenous People (MMIP)

A major focus of the second day of the annual meeting was the MMIP crisis. Two OSBI Special Agents, Dale Fine (Cherokee) and Joshua Patzkowski (Cherokee), were joined by LaRenda Morgan (Cheyenne and Arapaho), MMIP advocate and Founder/President of the Cheyenne and Arapaho Tribes' MMIP Chapter.

The passage of Oklahoma's Ida's Law in 2021 helped create both Fine's and Patzkowski's positions at OSBI. Morgan led the effort to pass the bipartisan law, which is named after her first cousin Ida Beard, a Cheyenne and Arapaho citizen who has been missing since 2015. Morgan discussed the heartache and anguish families experience when a loved one goes missing. "We'd never had anyone in our family go missing," Morgan said. "People in our Indian communities don't talk about this." Ida's Law was designed to improve collaboration between tribal, state, and federal agencies in cases of missing and murdered Indigenous people. The OSBI can provide fingerprint and DNA analysis, help log information into the missing persons database or add an extra pair of eyes to a case that's gone cold. However, the panelists all agreed that challenges still exist. They acknowledged one of the greatest challenges is still related to jurisdiction. If local, county or Tribal law enforcement receives a missing persons report, the reporting agency must formally request OSBI support before the

state agency can intervene. Special agent Fine outlined the agency's progress in addressing MMIP cases but stressed that education and resources are tools not yet fully realized in Tribal communities.

"When a young person is in an abusive relationship, we need to make sure they know there are resources available to them, and they don't have to go back into that situation," he said.

Fine also stated he looks forward to digging into several cold cases involving MMIP.





NOTICE AND RULES OF GENERAL PRIMARY ELECTION WEDNESDAY, MARCH 5, 2025



Notice is hereby served to all eligible voters of the Ho-Chunk Nation that the Ho-Chunk Nation Election Board, in accordance with the Constitution of the Ho-Chunk Nation has called a General Primary Election. ARTICLE VIII – ELECTIONS and the Election Code (2 HCC Sec. 6), states in relevant part:

3. Elections, c. Primary Election and Runoff Elections.

(1) Primary Elections shall be held prior to an Election with three (3) or more candidates in order to ensure compliance with the majority vote requirement as provided for in paragraphs 1c and 1e. (2) If no candidate in any Primary Election receives more than 50% of the votes cast in such Election, the two candidates with the highest vote totals from the Primary Election (and any candidates tied with the lower of such totals) shall appear on the ballot in the Runoff Election. When there are two (2) seats vacant in a district, the top two (2) vote getters for any vacant seats, if no candidate has received 50% + 1 vote, shall be on the ballot for the General Election or Runoff Election. (3) Primary Elections shall be conducted in the manner prescribed by this Code and in accordance with the timetable adopted by the Election Board.

THE FOLLOWING TERMS OF FOUR (4) YEARS WILL BE VACANT:

LEGISLATURE: District 1, Seat 1 July 2025 – June 2029

NOMINATIONS OF CANDIDATES

The official candidacy forms may be obtained from the Election Board Members or the Election Board Office. A candidate for elective office shall submit an Official Nomination Petition, Declaration of Candidacy and a \$5.00 filing fee MUST be hand delivery or U.S. Mail to the Election Board office before the close of the nomination period on <u>Sunday, January 19,</u> <u>2025 by 4:30 pm.</u> ORIGINAL FORMS MUST BE SUBMITTED. FILING BY FAX OR COPIES WILL NOT BE ACCEPTABLE.

ELIGIBLE VOTERS:

Any enrolled member of the Ho-Chunk Nation who is at least eighteen (18) years old and who has resided in their respective district for at least three (3) months. *See Election Board Code Sec. 11 (c).* **REGISTRATION:**

Each person seeking to vote must register at the polling place. If a person cannot write, that person must sign his/her name with a mark before two (2) witnesses. A Ho-Chunk translator will be available to assist any tribal member who requests assistance.

ELIGIBILITY DISPUTES:

Any individual whose name does not appear on the eligible voters list can claim the right to vote by presenting a written challenge to the Election Board. Any eligible voter may challenge the eligibility of an individual's name appearing on the eligible voters list by presenting a written challenge to the Election Board.

The Election Board will rule on all written challenges to the list of eligible voters immediately after the close of the challenge period. Section 11(c) iii, (Deadline Thursday, February 13, 2025).
