Reclaiming Wellness the Native Way

ThunderMaker Wellness, founded by Ho-Chunk tribal member Hunter Thundercloud, is helping to reshape the way recovery and mental health care are delivered in Indian Country.

Based in Arizona, ThunderMaker Wellness focuses on substance use and mental health healing through a holistic lens. The program ranges from six months to two years, beginning with a stabilization phase before transitioning into apprenticeships that teach life and vocational skills.

"Our goal is more than just treating the symptoms," Thundercloud said. "We want to instill pride, cultural identity, and real-life skills that can be carried with them long after they leave."

Thundercloud's vision for ThunderMaker was shaped by his own recovery journey. After battling addiction for several years and facing incarceration, he entered treatment

eight years ago.
"I had three DUIs by 25 and did nine months in jail. I realized I couldn't keep drinking," Thundercloud said. "I got into heroin after that and struggled for six years before my parents sent me out here for treatment. My dad said, 'I'm not going to let my son die."

What began as a personal

transformation became the foundation for ThunderMaker Wellness.

'When I got clean, I started a sweat lodge at my house. That's where I found my spiritual awakening," Thundercloud said. "Culture saved my life.'

Over time, he and co-founder Arrow Funmaker, who was also working in behavioral health, built a program rooted in both clinical and cultural practices.

Today, ThunderMaker operates as a long-term recovery program offering psychiatric and medical care alongside cultural programming like sweat lodge, drum circles, and medicine harvesting. The center also partners with local farms to provide traditional foods through a food sovereignty program.

"Lots of people in addiction don't have stable lives," Thundercloud said. "We focus on teaching basic skills, how to cook, clean, and maintain a home, while surrounding them with ceremony and community."

The facility currently has 17 beds, with renovations underway to expand to more than 30. All of ThunderMaker's upper management and clinical leadership are Native, ensuring that the program remains grounded in Indigenous worldviews.

'The culture stuff we do, we don't have to ask anyone for permission,"

Thundercloud said. "Everything we do is through a Native lens."

ThunderMaker also hopes to launch a women's program soon.

"The way women experience addiction and trauma is very different from men," Thundercloud said. "We want to make sure that program is 90 percent womenrun and built specifically for their needs."

ThunderMaker Wellness stands as proof of what's possible when recovery is guided by identity, ceremony, and love for community.

"If no one knows we exist, how can we help anyone?" Thundercloud said. "My goal is to build something that works, and then bring it home to our people.'

Executive Order November 7, 2025-1

Emergency Declaration for Temporary Food Assistance Program

WHEREAS, the Ho-Chunk Nation has a Constitutional responsibility to advance the general welfare and safeguard our interests, along with the inherent responsibility to protect the health, welfare, and well-being of its tribal members; and

WHEREAS, the Ho-Chunk Nation recognizes that the upcoming disruption in access to Supplemental Nutrition Assistance Program (SNAP) and FoodShare Electronic Benefit Transfer (EBT) services, beginning in November 2025, will cause immediate hardship to families who rely on these benefits for essential food security; and

WHEREAS, many Ho-Chunk tribal members, their families, and other eligible Native households residing within the Nation's service areas depend upon these benefits as their primary source for purchasing groceries and essential nutrition; and

WHEREAS, the Ho-Chunk Nation finds it necessary to take immediate action to prevent food insecurity, malnutrition, and undue hardship among its members and residents impacted by this disruption; and

WHEREAS, the President of the Ho-Chunk Nation, under the authority granted by the Constitution of the Ho-Chunk Nation, Article VI, Section 1(a) and Section 2 is empowered to issue Executive Orders in times of emergency to safeguard the welfare of the Nation and its citizens;

NOW THEREFORE, I, Maassusga (Jon Greendeer), President of the Ho-Chunk Nation, do hereby declare the following:

Section 1. Declaration of Emergency

An emergency is hereby declared due to the suspension or disruption of SNAP/FoodShare benefits, which threatens the food security and welfare of affected citizens and households.

Section 2. Establishment of the Ho-Chunk Nation Emergency Food Assistance Program

A temporary emergency assistance program and a Special Restricted Account is hereby established to provide direct grocery support to individuals and families currently receiving SNAP/FoodShare benefits who are unable to access their federal benefits.

Section 3. Eligibility

Eligibility for this emergency program shall be subject to the following requirements:

- Must be an enrolled Ho-Chunk Nation tribal member who is a <u>current</u> recipient of SNAP/FoodShare benefits
- Applicants MUST be able to provide verification of SNAP/Foodshare participation through documentation from their MyAccess account Certificate of Eligibility and/or other verifiable benefit statements.
- Applicants must complete a short application form to ensure verification, accountability, and administrative/fiscal tracking of disbursements.

Section 4. Distribution of Assistance

- Eligible applicants will be issued a direct deposit as a General Welfare supplement in the same process as the GW monthly payments are administered. Payments will be equivalent to the program schedule contained within this Order and designated as unreportable income for tax purposes.
- 2. The card value shall be **based on the individual's verified household dependents SNAP/FoodShare benefit amount** based on the following schedule:

Registered SNAP Household Dependents	Amount Supplement	
1	\$200	
2	\$300	
3+	\$500	

- 3. Recipients must reconcile their assistance by **submitting their grocery receipts totaling the amount provided** within 30 days of receiving the assistance.
- ${\it 4.} \quad {\it Funds may be used only for the purchase of eligible grocery and household food items.}$

Section 5. Administration

The Ho-Chunk Nation Office of the President along with designated departmental staff shall verify program eligibility through properly submitted documentation. Once verified, ONLY the applicant's name and payment amount will be forwarded to the Department of Treasury for processing. Only information necessary to process payment will be shared outside of applicant verification.

Section 6. Funding

Funds to support this program shall be allocated from the Nation's emergency reserve established by this Executive Order of the Declaration of Emergency and Legislative Resolution.

Section 7. Duration

This Executive Order and the emergency program established herein shall remain in effect for **60 days** from the date of issuance, unless the following take place:

1. The US Federal Government takes action to provide full restoration of SNAP/Foodshare benefits through the use of unutilized program contingency funds

- The US Federal Government resumes regular SNAP benefits by function of resolving the government shutdown and reinstating operation(s) and timely distribution of benefits
- 3. This Order is extended by further Executive Order or Legislative action

Section 8. Effective Date

This Executive Order shall take effect immediately upon signature.

Placement and Respite Homes Needed

Do you have room in your home for children? Are you currently not able to make a long-term commitment for placement of a child? Are you looking to make a difference in the life of a child? Here's

The Ho-Chunk Nation Child and Family Services is looking for respite care providers in all areas near Tomah, Wisconsin Dells, Nekoosa, La Crosse, Green Bay, Wittenberg and Black River Falls. Respite care is short-term care (one day to two weeks) provided to children who are in out-of-home placement. Respite providers are reimbursed \$50 per day per child and are also provided gift cards for food. For emergency respite, the respite rate may be increased. You do not have to be an enrolled tribal member to become a licensed Placement or Respite Home provider!

Respite providers are an integral part of a team of individuals who are looking out for the best interest of children. Relative Placements, Respite Providers and Placement Parents are required to have Federal Criminal Background Checks (fingerprints) (25 U.S.C. "Indian Child Protection and Family Violence Prevention Act").

Closing out the fourth quarter, we reflect on a strong fiscal year marked by significant financial milestones. In September, Twelve Clans leadership met with the owner's representatives in a hybrid format, combining both in-person and virtual participation.

During this update, we were pleased to welcome and congratulate Representatives Kyle White Eagle, Sandra Whitewing, Edward Mullen, and David Greendeer on their recent appointments, as well as Representative Lambert Cleveland, Jr. on his appointment as Vice President.

The project is ahead of schedule and is set to open its doors to tenants in spring 2026. Woosley reported that the project has secured \$1.8 million in cost savings through vendor and subcontractor negotiations, and only deploying \$141,872 of the contingency fund demonstrating strong financial management by the development and construction teams.

Financial Updates End of Year Portfolio

TCI ended the fiscal year with total assets of \$27.5 million and generated net income of \$2.38 million. Our annual asset growth was 9.5%, and we achieved a return on assets of 9.5%. Although we fell just short of our growth targets, this was primarily due to modest performance within our existing private equity investments, which comprise 54% of our asset base

Ongoing uncertainty surrounding higher interest rates and tariff policies also contributed to slower growth. Despite these headwinds, we achieved several successful outcomes within our private equity portfolio

Ho-Chunk Nation Launches Emergency Food Program as SNAP Funding Stalls Amid Federal Shutdown

The Ho-Chunk Nation has declared an emergency to ensure tribal members relying on federal food assistance don't go hungry during the ongoing government shutdown.

President Jon Greendeer issued an Executive Order on November 7, 2025, creating a temporary food-assistance program after the federal Supplemental Nutrition Assistance Program (SNAP), known in Wisconsin as FoodShare, was disrupted by the shutdown.

The move allows the Nation to use its own emergency reserve funds to provide direct grocery support for enrolled members currently on SNAP/FoodShare.

"An emergency is hereby declared due to the suspension or disruption of SNAP/FoodShare benefits, which threatens the food security and welfare of affected citizens and households," the order states.

Under the new Ho-Chunk Supplemental Assistance: SNAP FoodShare program, enrolled tribal members who are current recipients of SNAP/FoodShare may apply for limited grocery support through the Nation's website.

Applicants must verify participation in the federal program using their MyAccess account documentation and complete a short application. The Nation will issue direct deposits as general welfare supplements in the same process used for its monthly payments.

Households with one dependent will receive \$200, those with two dependents will receive \$300, and families with three or more dependents will receive \$500

Funds must be used for groceries and essential food items, and recipients are required to submit receipts totaling the amount provided within 30 days. The program will remain active for 60 days or until federal benefits are restored.

The urgency behind this action comes as nearly 700,000 Wisconsinites, including about 270,000 children, depend on FoodShare each month.

The state typically distributes about

\$125 million in benefits monthly, according to the Wisconsin Department of Health Services. But with the shutdown freezing federal payments, many families have been left uncertain about how to cover their basic needs.

Governor Tony Evers condemned the federal government's handling of the situation, emphasizing that Wisconsin acted lawfully and compassionately by ensuring families still received their FoodShare benefits.

"Pursuant to and consistent with an active court order, Wisconsin legally loaded benefits to cards, ensuring nearly 700,000 Wisconsinites, including nearly 270,000 kids, had access to basic food and groceries," Evers said. "After we did so, the Trump Administration assured Wisconsin and other states that they were actively working to implement full SNAP benefits for November and would 'complete the processes necessary to make funds available.' They have failed to do so to date."

President Greendeer's executive

order notes the Ho-Chunk Nation's constitutional duty to safeguard the welfare of its citizens, saying the disruption to SNAP would cause immediate hardship to families who rely on these benefits for essential food security.

By creating its own emergency program, the Nation is demonstrating a strong example of tribal sovereignty and community care, one that other tribal governments may look to replicate if the shutdown continues.

Food insecurity in Wisconsin affects roughly one in ten residents, with Native households often experiencing even higher rates due to limited grocery access and increased food costs. About 40 percent of FoodShare recipients statewide are children, while seniors make up around 12 percent of those receiving assistance.

"Whether the funding is restored or not," the Nation's public announcement read, "we want you to know we are here for you."



BPDD and DPI believe more families and their children with disabilities will connect with the people, activities, and community resources they need to live the lives they want.

"We are excited to invest in these groups that are trusted community resources and already are making important impacts on families' lives through both group education and individualized supports. We know that when families have the information and support they need, they and their children succeed," explains Beth Swedeen, Executive Director for the Wisconsin Board for People with Developmental Disabilities.

With the current uncertainty surrounding the FoodShare program, the Ho-Chunk Nation Food Distribution Program (FDPIR) would like to provide information on how we may be able to assist.

To qualify for food assistance through our program, applicants must first cancel their FoodShare benefits and provide documentation confirming the cancellation. Please be advised that if you choose to cancel your FoodShare benefits, you will need to reapply should you decide to return to that program once funding resumes. Be aware that delays may occur in reinstating your FoodShare benefits upon reapplication.

If canceling FoodShare benefits is not an option you wish to pursue, we encourage you to contact local food pantries in your area for assistance. In Wisconsin, you can dial 2-1-1 to receive a comprehensive list of local food pantries and their hours of operation. You may also visit the Feeding America website or the Hunger Task Force website for additional

DNR Asks Public To Report Black Bear Den Locations For Research Study

MADISON, Wis. – The Wisconsin Department of Natural Resources (DNR) encourages the public to report any black bear den locations across the state to help with an ongoing study on black bear reproduction.

The Black Bear Litter and Diet Survey will generate new estimates of black bear reproductive rates within each of the state's bear management zones. These estimates will improve the accuracy of the population models used in each zone. Additionally, researchers are investigating a connection between consumption of human food sources and bear reproduction, since diet can affect cub survival rates and litter sizes.

The study will be entering its fifth year of surveying occupied dens in the Wisconsin bear range. The research team will accept a den report anywhere in the state. However, the team is particularly interested in finding dens in bear management zones C, E and F, which cover central and southern Wisconsin. Having collared bears in every zone will improve population estimates for each respective zone and support management decision making.

The public's assistance is essential to this project, and anyone who happens upon an occupied black bear den is encouraged to report as much information as possible without approaching or disturbing the animal. Reporting dens helps the DNR meet the sample size requirements for our study and will increase the accuracy of the black bear population estimates.

If you believe you have found a black bear den, please collect the following information quickly and quietly while remaining a safe distance of at least 30 yards from the den at all times:

• GPS coordinates: You can use a mobile

phone's pre-installed map app, such as Google Maps or Apple Maps. For best results, first go to your phone's Settings and turn on the option to improve location accuracy.

- Photos of the den: Maintaining a safe distance, take an image or two showing the den in relation to its surroundings.
- Description of the site and surrounding area: Take some notes on the size of the entrance, the direction it faces and whether there are notable landmarks nearby.
- Description of any bear activity in general area: Make a note of anything you observe, including pawprints, scat, fresh scratch marks and even, in late winter, the squeals and grunts of hungry cubs.

DATCP and DHS Urge Wisconsin Retailers to Continue to **Accept FoodShare**

Businesses should not refuse service, DATCP is prepared to enforce against price gouging

MADISON, Wis. - Retailers and grocery stores play an important role in ensuring FoodShare members can access healthy, nutritious food to feed their families. Today, the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) and the Wisconsin Department of Health Services (DHS) remind Wisconsin businesses who have signed up for the FoodShare program that FoodShare recipients have had funding legally loaded onto their cards and businesses cannot turn away members using QUEST cards at registers.

"It's been a really difficult and scary time for a lot of people because of the federal government shutdown and economic uncertainty, especially for families, kids, and seniors who rely on FoodShare. Wisconsinites are helpers by nature—it's part of our DNA. When things get tough, we always look out for and support our neighbors, and that's especially important now more than ever," said Gov. Tony Evers.

On October 31, Gov. Evers signed Executive Order #278, which prohibits price gouging due to the loss of FoodShare funding. It also calls on grocers and retailers to ensure relevant resources are readily available for Wisconsinites and the state, and state agencies can utilize every available tool and resource to support Wisconsinites through impacts of the federal government shutdown. The governor's executive order can be found here.

"While there haven't been reports of people being turned away or of price gouging thus far, we want to make sure everyone is clear on the expectations. No one in Wisconsin should have to worry about their next meal," said DATCP Secretary Randy Romanski.

FoodShare members receive benefits on a OUEST card, similar to a debit card, that allows them to pay for food at any business that has agreed to participate in the program. Current federal guidance states that consumers may continue to redeem the existing balance issued to their QUEST card at any authorized retailer. If FoodShare members are wrongfully denied the ability to use their QUEST cards to purchase food when they have a balance remaining, they should take the following steps:

• Tell store staff, "I have a balance on my QUEST card, and I am able to use it."

• Call Wisconsin's Consumer Protection Hotline at (800) 422-7128 or email DATCPHotline@ wi.gov.

"FoodShare is essential for Wisconsinites of all ages, whether they are working a low-income job, live on a fixed income, or are facing unemployment. Members rely on these benefits to keep them from having to choose between using money for food, or their rent, heating bills, or medicine," said DHS Secretary Kirsten Johnson.

FoodShare in Wisconsin provides basic food access for nearly 700,000 Wisconsinites, including nearly 270,000 kids.

At this time, full November FoodShare benefits continue to be available on all QUEST cards. Any Wisconsinite who needs additional food or infant formula for their house or family can reach out to 211 for information and referrals to local services. Anyone can use 211 to get help by:



- Ceexjį is a very lean and nutritious source of protein.
- Because it is so lean, bison has fewer calories than beef.
- As with many meats, the nutrition depends on the cut of meat and if it was fully grass-fed or grain-finished,
 - An example of a 3 ounce grass-fed bison burger is 152 Calories, 7g fat, 3g saturated fat, and 60mg cholesterol.

PREPARING

- Because it is a lean meat, it can overcook easily: slow cooking, braising or stewing are great options for bison meat.
- Ground bison should be cooked to 160°F, and steak and roasts should be cooked to 145°F.

STORING

- As with any meat, for best quality, cook ground, raw meat within 2 days and raw roasts or steaks within 3-4 days.
 After cooking, eat or freeze within 3-4

INGREDIENTS:

- o 2 lbs. ground bison
- o 1 small onion, diced
- 2 cans tomato sauce, no salt added (15 oz. each)
- ∘ ½ teaspoon black pepper
- ∘ ½ teaspoon garlic powder
- ∘ ¼ teaspoon cumin
- o 2 teaspoons chili powder
- ∘ ¼ teaspoon cayenne pepper
- o 1 ½ cups kidney beans, cooked, drained

STEPS

- In a large skillet, over medium-high heat, cook ground bison and onions until meat is brown and onion is translucent.
- 2. Drain any excess fat.
- 3. Add tomato sauce, spices, and beans
- 4. Let simmer on low for at least 20 minutes. Bison should reach a final internal cook temperature of at least 160°F, measured with a food thermometer before serving.



den, they will work with the den reporters and landowners to determine whether it is safe, accessible and in use. Den reporters, landowners and/or land managers are typically invited to help if there is a planned survey for the reported den. The research team may not be able to visit every reported den location this season; they will prioritize dens that are confirmed to be occupied.

What Data Will Be Collected

DNR staff will collect biological data from these dens, including sex, age, weight and body

measurements. Mother bears, or sows, will be outfitted with a GPS collar, one of the most important pieces of equipment for the study. Collars help staff learn more about bear foraging behavior and locate the sows in the future. Revisiting the sows will help staff determine the reproductive success of each sow, such as how often she has a litter, litter size and the survival rates of the cubs.

During a survey, bear health and safety are a top priority. Designated staff monitor the sow's breathing and heart rate while the rest of the team quickly gathers the needed samples and

measurements. Any cubs present at the den are carefully weighed and sexed. Cubs are tucked into team members' coats to keep them warm because the cubs cannot yet regulate their own temperature. Once researchers finish collecting samples and fitting the GPS collar, the sow and cubs are put back into their den. This process can be seen in a 2024 episode of PBS Wisconsin's "Wisconsin Life" series.

"I'm not a career politician, I'm a builder," said Rodney Rave, a proud member of the Ho-Chunk Nation's Bear Clan. "I grew up in an old shack with a dirt floor and spent 31 years in highway construction. I've seen what families, veterans, and

farmers are up against. The rules feel rigged and the costs keep climbing. I'm running to fix what's broken so government finally works for the people

Rave's candidacy centers on affordability with accountability, fair treatment for rural and Tribal communities, and a focus on practical solutions over partisan theater. As a former Ho-Chunk Nation legislator, he worked to expand access to addiction treatment and strengthen Tribal-state partnerships. As a union member and heavy-highway worker, he helped build the roads and bridges that keep western Wisconsin connected.

Rodney's Day-One Priorities

• Lower Costs You Can Feel: Crack down on price-fixing and junk fees, fight for fair competition that actually lowers grocery, utility, and prescription costs, and raise the minimum wage.

• Build Wisconsin, Build the Middle Class: Cut red tape to accelerate housing, roads, and broadband, creating good union jobs across western and northern counties.

• Healthcare & Recovery: Protect Medicare and Social Security, expand access to affordable care, including mental health and addiction recovery, so families can get help close to home.

Rodney is a Christian and traditional Ho-Chunk spiritual practitioner who lives by a simple principle: look out for everyone, love for all, and help others without asking for payment.

Sherry Ann Wilson, age 73, died at the Black River Memorial Hospital on October 26, 2025, in her hometown of Black River Falls, Wisconsin. She was born on August 10, 1952, to Rachel Funmaker. She was later adopted by Earl and Margaret Wilson.

Sherry lived a life dedicated to giving a voice to the marginalized and advocating for equality, particularly for Native Americans and women. Sherry was not only a gifted writer but also a talented radio host and voiceover artist for the Ho-Chunk Nation. Her commitment to her roots and her people led her to co-found MIGZI Communications- a program to help support indigenous youth. Sherry was known for her independent spirit and her unique sense of humor. She was not just a journalist; she was a human rights activist whose voice resonated with many, inspiring change and fostering understanding. Just a few of the many movements Sherry participated in in creating a voice for the others included: In 1985 in Nairobi, Kenya Global Conference on Women, Lac du Flambeau in support of Treat Right and sovereignty and

AIM and WAMM (Women Against Military Madness), Central American for the March for the Peace, NYC demonstrations for denouncing Columbus Day, Support for Political Prisoners at home and abroad, Greenham Common Women's Peace Camp in England, 1992 Superbowl mascot protest in Minneapolis, the march in Ottawa in support of Innu/ Nitassinan and further militarization and impacts, 1990 actions in solidarity with people of Kahnewake and Kahnesetake during the siege of Oka in Minneapolis, and many conferences and meetings for WARN and INCITE! in Chicago. Gov. Evers Demands Trump Administration Release Late School Aid Payments for 20 Wisconsin School Districts

Governor blasts Secretary McMahon for firing staff, efforts to dismantle Department of Education resulting in late school aid payments for school districts across Wisconsin

MADISON — Gov. Tony Evers sent a letter to U.S. Department of Education Secretary Linda McMahon demanding that she immediately release federal Impact Aid payments for 20 school districts across Wisconsin that serve over 21,000 Wisconsin kids. Schools were supposed to receive the first round of payments in October for federal school funding, known as "Impact Aid," which is used by schools for basic operations, such as payroll, transportation, programs, and new positions, among other

"I was shocked to hear from several eligible school districts in Wisconsin that October Impact Aid payments have vet to be issued. Additionally, the U.S. Department of Education has provided no guidance or timeline for when school districts can expect to receive these payments," Gov Evers wrote to Secretary McMahon. "Less surprisingly, this delay seems to be completely unnecessary and entirely self-inflicted by the Trump Administration, as you have apparently terminated nearly all staff in the Impact Aid Program as part of your

illegal efforts to completely dismantle and eliminate the U.S. Department of Education without Congressional

approval. "Wisconsin schools waiting to receive funding that has been inexplicably delayed is just the latest in a long list of examples of the real and harmful impacts you and your administration are inflicting on Wisconsin's kids and schools, particularly those in our rural communities," the governor continued.

Federal Impact Aid is one of the most flexible sources of funding allocated to eligible schools, enabling

school districts to hire and pay teachers, purchase instructional materials, and support student transportation needs. This is especially critical for eligible Wisconsin school districts, as many of these schools are in rural areas of the state and face unique transportation challenges. Twenty school districts located across Wisconsin, from Bayfield to Seymour to Black River Falls, received Impact Aid payments in federal fiscal year 2025, totaling over \$23 million. Most but not all eligible schools are operated by federally recognized Tribal

"This funding is critically important to many school districts in Wisconsin that receive reduced or no property tax revenues due to being located on federal lands. Refusal to fulfill your legal and statutory obligations by providing these payments to schools that support core operations is unacceptable and requires your urgent attention," Gov. Evers concluded. "Please take

- The 2023 GC Resolution did not ask the Legislature to seek a Secretarial Election
- Rather, the GC Resolution mandated that the Legislature change the Enrollment and Membership Code to reflect the change to 4/4 blood degree
- The Attorney General issued an Opinion finding that this change to the Enrollment Code could not be done, without violating the HCN Constitution.
- The Attorney General indicated that the Constitution would have to be amended first, to allow for such a change to be implemented.

In light of constitutional concerns, the Legislature did not take the action outlined in the 2023 GC Resolution. Rather, the Legislature adopted Resolution 10.31.23P, acknowledging the GC Resolution and referring it to a Legislative Workgroup to review the impacts of such an enrollment change on the Nation's finances and programs. The Legislative Workgroup did discuss this and even went through an RFP process to select a vendor to do demographic and impact research. Although a vendor was unofficially selected, no contract was entered into. Thus, the effort was stopped.

Rep. Phyllis Smoke continued with points about the proposed Legislative Resolution/Request:

- The Request asks the Election Board to conduct a Secretarial Election to amend the Constitution, at a meeting of the General Council. This is an option under Section 21.e(3) of the Election Code.
- The Request is made pursuant to Article XIII, Sec. 2 of the Constitution. Here, the Legislature does have the right to make such a request to the Election Board. Two-thirds of the entire Legislature must approve such a request.
- The Request is also made under Section 21.c and 21.e(3) of the Election Code. The Code request that the actual text of the proposed amendment be stated in the Legislative Resolution. (This is on page 3 of the Legislative Resolution.) And the Certification must list the full vote total of the Legislature, indicating who was in favor, opposed, or abstained.
- The Request must also specify how the Secretarial Election should be conducted (i.e., mail ballot, in conjunction with a General Election, or in conjunction with an Annual GC meeting). Here, it has been drafted to be at the same time as a GC meeting.

Rep. Phyllis Smoke noted one correction to the Resolution in front of the Legislature today would be to add that the secretarial election would take place at the 2026 Annual General Council Meeting.


